## **Terms of Appointment**

On behalf of the Company, I write to confirm your re-appointment as an Independent Non-Executive Director of the Granules India Limited (“Granules” or “Company”), as per the provisions of Companies Act, 2013 and regulation 17 and 25 of SEBI (LODR) Regulations, 2015.

The terms of your re-appointment are set out below. Please note that this is a contract for service and is not a contract of employment.

### **1. Appointment**

Your re-appointment is subject to confirmation by the Shareholders in the 28<sup>th</sup> Annual General Meeting following which, it is anticipated that the re-appointment will be for a second term of 5(five) years from April 01, 2019 up to March 31, 2024. This tenure is subject to you meeting the criteria for being an Independent Director and not being disqualified to be a Director under the applicable regulations. You shall not be liable to retire by rotation as per the Companies Act, 2013 and the Listing Regulations. ### **2. Commitments**

You will be expected to devote such time as is necessary for the proper performance of your duties and as an Independent Director, you will be involved in a number of Board and Committee meetings each year as may be decided by the Board from time to time. ## **Terms of Appointment**

On behalf of the Company, I write to confirm your appointment as Non-Executive Independent Director of Granules India Limited (“Granules” or “Company”), as per the provisions of the Companies Act, 2013 and regulations 17 and 25 of SEBI (LODR) Regulations, 2015.

The terms of your appointment are set out below. Please note that this is a contract for service and is not a contract of employment.

### **1. Appointment**

Your appointment is subject to regularization and approval by the Shareholders through Postal Ballot following which, your appointment will be for the initial term of 5(five) years from February 20, 2024 to February 19, 2029. This tenure is subject to you meeting the criteria for being an Independent Director and not being disqualified to be a Director under the applicable regulations. 


