#### **COOKIE POLICY**

Thank you for visiting our and/or our affiliate's ("Granules"/"We"/"Us"/"Our") website. We understand that your privacy is important to data subject ("You", "Your", "User") and we are committed for being transparent about the technologies we use.

## 1. About our Cookie Policy.

This cookie policy ("Cookie Policy") explains what cookies and other similar technologies are and how we use them. You should read this Cookie Policy to understand what cookies and other similar tracking technologies are, how we use them, the types of cookies we use i.e., the information we collect using cookies and how that information is used and how to control the cookie preferences. For further information on how we use, store and keep your personal data secure, see our Privacy Policy.

#### 2. What are Cookies.

Cookies are alphanumeric identifiers with small amount of data that is commonly used as an anonymous unique identifier ("Cookies"). These are sent to your browser from the website that you visit and are stored on your computer's hard drive. Please note, a cookie in no way gives us access to your computer/device and cookies cannot access any other information on your computer/device.

We majorly use the following types of cookies:

- Strictly necessary. Necessary cookies are essential for the website to function properly. These cookies ensure basic functionalities and security features of the website, anonymously such as accessing secure areas of the website. Therefore, we do not ask for your explicit consent for such cookies. For all other cookies, we give you the choice to provide us with explicit and informed consent.
- **Performance.** Also known as "statistics cookies", these cookies collect information about how visitors use a website, for instance which pages visitors go to most often and if they receive error messages. They are used to improve how a website works in future versions.
- Analytics. Analytical cookies are used to understand how visitors interact with the website.
  These cookies help provide information on metrics of the number of visitors, bounce rate, traffic source, etc.
- **Functional.** These cookies allow the website to remember choices you make such as username, language or region you are in and provide an enhanced personal experience
- Third-Party Cookies. Our website may also use third-party cookies which are placed on our website by third parties whose solutions have been integrated into our platforms. Such cookies include, but are not limited to, marketing cookies, targeting cookies. These cookies track your online activity between different platforms to present you with more relevant advertisements, products or services based on your preferences and search history. Such cookies may also enable you to view our promotional content using social media networks such as YouTube as well as on our social medial accounts on platforms such as Meta,

LinkedIn and Twitter, when accessed from our website. These cookies can share that information with other organizations or advertisers. Such cookies are always optional, and you may choose to consent to them.

• Others. Other uncategorized cookies are those that are being analysed and have not been categorized yet.

#### 3. How do we use Cookies.

Our website uses these cookies to collect information and to improve our service by making your interaction with us faster. It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period, to avoid re-entering the data upon re-visiting the website or browsing from one page to another. They may be used for the purposes of managing your preferences, maintaining and optimizing security, marketing, communication, analytics, and research.

The first-party cookies are mostly necessary for the website to function the right way.

We also use third-party cookies that help us analyse and understand your usage of this website. These cookies will be stored in your browser only with your consent.

Other tracking technologies. Our website uses cookies, Web Beacons and other web technologies such as CAPTCHAs (sometimes referred to as web server logs and/or tracking pixels) to improve our website's performance and to enhance your browsing experience. These technologies are designed to provide usage information for purposes of analysing and improving the performance of the services we provide to you.

#### 4. Third-Party Plug-ins.

All information about the role of third-party in processing the data collected via cookies or other tracking technologies is included in our Privacy Policy. The cookies may allow us and our third parties to collect the following information about you:

- data relating to your device (including device ID, MAC address, IP address, operating system, device settings, in particular the language settings, screen resolution, type of web browser, etc.);
- data relating to your visits to our website (including time and length of your visit, date, subpages visited on our website, search data, etc.);
- your location (if you have provided your separate consent)
- information about advertisements you have viewed, including information about links you have clicked;
- information about advertisements you have viewed, including information about links you have clicked; and
- information about your activities on other website (if you have provided your separate consent), including information on the other website you visit and the frequency of the visits.

## 5. What is the legal basis for processing?

The basis under which we process your personal data depends on several factors, the personal data being processed itself, as well as the business purpose for which we are processing it. These bases may include:

- your consent (in line with Article 6(1)(a) of the General Data Protection Regulation (GDPR))
  with respect to cookies which require a consent; or
- under our legitimate interest (in line with Article 6(1)(f) General Data Protection Regulation (GDPR) with respect to cookies which are necessary to operate the website;
- your explicit consent (in line with Section 4(1)(a) of The Digital Personal Data Protection Act of India (DPDPA)), which is required to process your personal data;
- other data privacy laws in the US;
- to establish, exercise or defend legal claims;
- to perform a contract (e.g., to compensate a person);
- to perform a task in the public's interest (i.e., to avoid a major public threat); and/or
- to protect the vital interest of the person (e.g., safety or survival of the person)

You have the right to withdraw your consent at any time or object to processing of your personal data made under our legitimate interest. To withdraw your consent, you may contact us in accordance with our Privacy Policy. Any processing of the personal data before the withdrawal of the consent shall not be held unlawful.

This will re-display the consent notice enabling you to change your preferences or withdraw your consent entirely.
